- Small Farm Currently under construction (12/17/2020) in West Columbia
 - o \$30 \$35 million new capital investment for battery and related components which are in a container similar in size to a TEU ship container.
 - o Numerous batteries and containers will be in the battery farm.
- Large Farm Rural Brazoria County
 - o \$100 million new capital investment
 - o Currently under review and study by the company to determine the feasibility of constructing the large battery farm.

Peaker Power Plants

- Two natural gas-powered peaker power plants brought on-line remotely when the grid has a need for more electricity.
- Two potential sites in Brazoria County one outside of Angleton and the other near Rosharon.
- \$220 million new capital investment (\$130 million for Angleton plant and \$90 million for Rosharon plant)
- Pursuing incentives tax abatement or Chapter 381 grants and Chapter 313 before making final decision to build the power plants.
